(3) SYLLABUS

Since the 2022–23 academic year, two officially established studios have been operating within the department under the Sculpture specialization, each with a distinct focus within the field of contemporary sculpture. The subject matter, teaching methods, and research approaches are defined and regularly updated by the faculty members leading the studios. The content of the 3rd semester course in the Sculpture specialization is programmatically connected to the other sculpture courses and places particular emphasis on the development of artistic thinking. It aims to deepen students' understanding of the sculptural language through the use of methodological tools for expressing, designing, and realizing ideas—both within the three-dimensional space of sculptural practice and in relation to contemporary approaches to sculpture as an expanded visual art form. The course is structured along two main axes:

A. Studio-Based Exercises

These focus on fostering the student's visual inquiry and artistic research. Studio work includes the execution of individual and group projects, thematic assignments involving both structured "disciplinary" challenges and exercises in "free expression." Emphasis is placed on:

- 1. The perception of three-dimensional space in sculptural practice
- 2. Contemporary approaches to sculpture as an expanded visual art practice

B. Presentations and Lectures

These are designed to support and enhance the studio component while also shaping students as active participants in the visual arts within the broader social and cultural context.

Description of the evaluation procedure

Assessment is conducted in two phases (midterm progress and final examination period) and is based on the work completed in the studio, as well as the overall fulfilment of the examination requirements. It involves the exhibition/presentation in the studio of the visual projects produced, taking into account the degree of responsiveness to the assignment criteria, thematic consistency, clarity of the written component, preparation and technical skill, as well as the demonstration of well-informed critical thinking. All discussions related to the evaluation of examination deliverables take place in the presence of all students participating in the examination process. The assessment criteria are accessible to students both in the studio and via the e-course platform.
